#### DECISION

# No. 325 of 02.06.2015

# on the Reorganization of the State Enterprise "State Agency on Intellectual Property"

Published: 12.06.2015 in the Official Gazette No. 144-149 Article 376

In order to implement the provisions of Law No.114 of 3 July 2014 on the State Agency on Intellectual Property (Official Gazette of the Republic of Moldova, 2014, No.282-289, Article 600) and based on Article14 of Law No.146-XIII of 16 June 1994 on the state enterprise (Official Gazette of the Republic of Moldova, 1994, No.2, Article 9), as subsequently amended and supplemented, the Government DECIDES:

- 1. To reorganize, by means of transformation, the State Enterprise "State Agency on Intellectual Property" into the Public Institution "State Agency on Intellectual Property" (abbreviated—AGEPI) subordinated to the Government.
- 2. The Public Institution "State Agency on Intellectual Property" shall be the successor of rights and obligations of the State Enterprise "State Agency on Intellectual Property".
- 3. The assets of the State Enterprise "State Agency on Intellectual Property" shall be transferred under the management of the Public Institution "State Agency on Intellectual Property".
- 4. Employment termination in connection with the reorganization of the State Enterprise "State Agency on Intellectual Property" shall be carried out in accordance with the legislation in force.

# 5. To approve:

The organizational structure of the Public Institution "State Agency on Intellectual Property" according to Annex1;

The amendments made to some Government decisions, according to Annex 2.

6. To mandate Mrs. Lilia Bolocan, Director General of the State Enterprise "State Agency on

Intellectual Property" with the right to perform all necessary measures in order to achieve the reorganization process of the State Enterprise "State Agency on Intellectual Property" and to register the Public Institution "State Agency on Intellectual Property" in accordance with the provisions of the legislation in force.

- 7. To repeal some Government Decisions, according to Annex3.
- 8. Control over the execution of this Decision shall be charged to the State Chancellery.
